

Local plan for Mitchell, Dunkeld, Begonia and District

This local community plan is a direction-setting document with objectives setting out “what” the district communities, businesses, government agencies and Council propose for Mitchell, Dunkeld, Begonia and District.

Action plans will set out “how” the objectives are to be achieved. They are separate documents. Action plans are prepared when people, organisations, businesses or governments are ready to provide leadership and allocates resources to a project.

The objectives in the local plan are to be read in conjunction with Maranoa region-wide objectives (refer to the Maranoa region-wide strategies for Business & Industry, Tourism, Arts & Culture, Sport & Recreation and community lifestyle in the *Maranoa Economic and Community Plan*).

Because the objectives in this local plan have community support, the objectives can be used by local organisations and businesses to support applications for grants and other funding.

Local plan for Mitchell, Dunkeld, Begonia and District

The Mitchell, Dunkeld, Begonia and district has a rich history and strong Indigenous community bonds. The district economies are based on agricultural industries, primarily livestock, grain, timber and gas. Tourism retains its growth potential, as part of a visitor economy that encompasses sporting events, heritage, indigenous culture and recreational activities. The expansion of gas industry activity is starting to occur.

The district has a rich indigenous history with the Yumba indigenous culture facility having a central role in presenting the Gunggari peoples' culture to a wide audience

Features of Mitchell and the surrounding district are its agriculture, Mitchell Artesian Spa, Yumba indigenous culture facility and its bushranger sites and stories. Mitchell positions itself as the gateway to the outback. The Neil Turner Weir near Mitchell is one of the two large waterbodies in the Maranoa region which are capable of supporting a wide range of water-oriented recreational activities.

To anchor Mitchell as a major Outback destination, it is the proposed location for a bushranger and cattle duffing experiential museum, using the old Mitchell Courthouse as its base.

Mitchell is the service centre for the surrounding districts, including the Mungallala and Amby districts. The services provided in Mitchell reflect its one hour drive time from the Maranoa regional centre of Roma. The Mitchell CBD will benefit from a stronger focus on tourism.

Health, education, Council and government services, transport, timber and accommodation are major employers in Mitchell. A Corrective Services workcamp provides support for community projects.

The Dunkeld State School, Dunkeld Hall, and adjacent recreation areas (including the golf course and pony club) are anchors for the surrounding grazing community.

The Begonia community sits on the Mitchell St George Road and the Maranoa River which flows through Mitchell. It is oriented towards Roma, St George and Mitchell for its services and social connections.

Many of the broader aims for the Mitchell, Dunkeld and Begonia district local communities are set out in the Maranoa-wide objectives contained in the *Maranoa Economic and Community Plan*. This Mitchell, Dunkeld and Begonia district local plan sets out those local objectives which are specific to the Mitchell, Dunkeld and Begonia district community. These local objectives provide the framework for local action plans.

NOTE:

References to the "Maranoa region" in this document refer to the Maranoa Regional Council Area as defined by the Queensland Government.
